AFTER REVIEWING THE CASE OF ARMY MIA ROBERT W. HUNT: DIA SCUITIER BELIEVES THERE IS A VERY STRONG LIKELIHOOD THAT HUNT IS THE INDI-VIDUAL ERRONEOUSLY IDENTIFIED AS JAMES J. SCUITIER ON THE PRO MILITARY DIEDEIN-CAPTIVITY LIST, 27 JANUARY 1973.

HUNT AND SCUITIER WERE PASSENGERS IN THE SAME PERSONNEL CARRIER THAT WAS AMBUSHED ON 28 FEBRUARY 1968 IN THE VICINITY OF XT 742 014, GIA DINH PROVINCE, SCUITIER AND A THIRD PASSENGER DID NOT SURVIVE" THEIR BODIES WERE RECOVERED THE NEXT DAY, BUT THERE WAS NO SIGN OF HUNT. SUBSEQUENT INTELLIGENCE REPORTING INDICATED A GOOD POSSIBILITY THAT HUNT WAS CAPTURED. ACCORDING TO THE PRG DIED-IN-CAPTIVITY LIST, "SCUITIER" WAS CAPTURED ON AN UNSPECIFIED DAY IN MARCH 1968 (IMPLYING UNE CERTAINTY AS TO THE EXACT DATE) AND DIED ON 10 MARCH 1968. THE SHORT CAPTIVITY PERIOD SUGGESTS THAT THE INDIVIDUAL CAPTURED BY THE VC POSSIBLY WAS WOUNDED AT TIME OF CAPTURE AND DIED OF HIS WOUNDS OR WAS SHOT BY HIS CAPTORS IN AN ESCAPE ATTEMPT. INDEED. ACCORDING TO THE SOURCES OF TWO REPORTS WHICH CORRELATE WELL TO HUNT, HE WAS WOUNDED IN HIS INCIDENT! ALTHOUGH NOT NECESSARILY SERIOUSLY! WITHOUT PROPER MEDICAL ATTENTION, HOWEVER, COMPLICATIONS
